- (10) To enter into contracts, partnerships and service delivery arrangements as may be required for the implementation of the Smart Cities Mission.
- (11) To determine and collect user charges as authorized by the Urban Local Bodies.
- (12) To collect the user charges from the end users in order to repay the loan (if raised), maintain operation and maintenance cost of the assets created under the Smart City Mission.
